I. CALL TO ORDER & ESTABLISHMENT OF QUORUM

A. Call to Order

Dr. Catherine Watkins, President of the Board, called the business meeting to order at 8:34 a.m., Wednesday, May 15, 2024, at the Thistle Golf Club in Sunset Beach, North Carolina. Dr. Watkins read the following statement regarding conflicts of interest as a reminder to all Board members:

A. Teledentistry

Dr. Litaker made a motion that Mr. Brocker draft a response informing Marty Folliard, of K&L Gates LLP law firm, that the proposed teledentistry model as presented is not permissible under the NC Teledentistry statute and the Dental Hygiene Act. Dr. Watkins seconded the motion. The motion carried.

Dr. Hardesty made a motion to move into closed session, pursuant to NCGS §143-318.11(3), in order to receive the advice of legal counsel. Dr. Litaker seconded the motion, which passed by general consent. Following advice from legal counsel, and without taking action, Dr. Hardesty made a motion to move into open session in order to vote on how to proceed in this matter. Dr. Litaker seconded the motion, which passed by general consent.

Mr. Brocker informed the Board of an ongoing investigation into the unlicensed practice of dentistry. Dr. Hardesty made a motion to allow the investigative panel to initiate a lawsuit through the NC Court System. Mr. Totman seconded the motion. The motion carried.

E. Guidance – unauthorized practice of dentistry Mr. Brocker
The Board does not wish to pursue individuals who are placing gems on teeth if they are not altering tooth structure during the placement process nor providing any other dental services.

Mr. Brocker reported on the hearing that was held on May 7, 2024, on the Motion for Injunctive Relief filed on behalf of Dr. Andrew Kelly for a stay of the Board's Final Agency Decision revoking Dr. Kelly's dental license, which was entered on April 22, 2024. After the hearing, the court informed the parties that it would deny Dr. Kelly's motion for injunctive relief and the Dental Board's Final Agency Decision revoking his dental license became effective May 9, 2024. Dr. Kelly's petition for judicial review will be scheduled at a future date.
