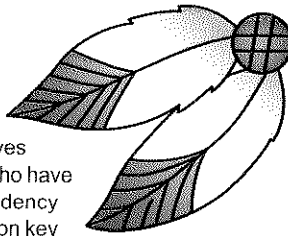


**CONTEMPORARY SEDATION OF CHILDREN FOR THE DENTAL PRACTICE:**

## COURSE SUMMARY



The focus of this course is sedation for the child patient who receives dental care. The course is primarily developed for pediatric dentists who have had training in sedation techniques during their graduate or residency training programs. Although the course involves a series of lectures on key topics associated with sedation (e.g., monitoring of the patient), materials are provided that include a narrative on issues such as child personality and selection of drugs and a reference list.

The course is consistent with the ADA's Part III: Guidelines on the Comprehensive Teaching of Pain and Anxiety in Dentistry in a Continuing Education Program. The level of the course, according to the ADA's Part III Guidelines, is that of a survey course and does not offer direct, clinical patient management.

## OBJECTIVES

Upon completion, the participant should be able to:

- Describe the pediatric anatomy and physiology of the respiratory, cardiovascular and central nervous system related to sedation.
- Describe the pharmacological effects of sedative agents used in pediatric sedations.
- Describe the appropriate physical assessment of the pediatric patient including risk assessment.
- Choose the most appropriate sedative for the individual pediatric patient based on behavior, temperament and dental needs.
- Describe and choose the appropriate monitoring equipment.
- Describe and discuss guidelines associated with the sedation of pediatric patients.
- Describe the use of nitrous oxide when used in combination with other sedative agents for use in pediatric patients.
- Discuss the advantages and disadvantages of sedation.
- List the complications associated with sedation of the pediatric patient.
- Discuss the prevention, recognition and management of these complications.
- Discuss the pharmacological effects of combined drug therapy, their implications and management.

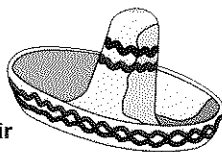

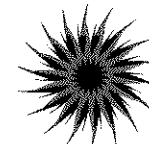

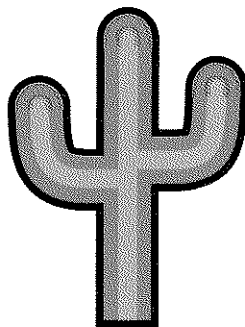
